ICTH Summary

Disruptive technologies are advancing at an increasingly rapid pace. This means that the rate of change that society is experiencing is not just accelerating, but that the acceleration is accelerating. This phenomenon has already had a noticeable impact on mobility and is a key driving force behind the Smart City concept.

It is anticipated that there will be transformational changes to transport service capabilities within the short time that it will take to plan, design and implement the conventional infrastructure project. That being said, state and local agencies must be flexible enough to accommodate the changes expected in technology over the next few years. In particular, the probability that fully autonomous self-driving vehicle will become commercially available by 2020. This alone, would be a game changer, and directly impact transport services delivery and the quality of life within affected communities. A look forward today will ensure that the demands of a diverse and growing population are met, thereby making local communities an attractive place to live, work and play.

Innovation and advances in disruptive technologies require a degree of future-proofing to anticipate and develop methods to minimize stresses through strategic planning and sustainable activities to ensure the value of the transportation system. ICTH 2019 aims to provide valuable insights into the health impacts of technological disruptions in transport and urban design, performance tools and the potential return on investment of a dynamic transport system.
